The archer is shooting his arrow. He shoots for nothing and has all his skill. But if he shoots for a prize he becomes nervous. The better the prize, the more nervous. His skill has not changed, but the prize begins to divide him. Now he cares about winning, the prize is more important than the joy of taking part. The need to win drains him of his power. *(An ancient Chinese proverb).*

What prizes do we crave in life? The prizes of wealth, prestige, power, possessions? Honestly? The more we reach out for these kinds of things, so the more we want. So we are never happy. This really is the root of addiction. We need more and more of what isn't working. And our lives are controlled by these powers. Such powers we might call "possession", presences pushing us to need things that aren't really me. Things that are so self-destructive. And yet our great Saints are people who needed less and less. Isn't that partly why they are Saints?

So, before things become compulsive, obsessive or addictive, we are called to let go. Let go of these insatiable needs. Cravings that so divide us (and families) up, we don't know who we are anymore.

Remember Adam and Eve? Adam grasped at divinity, wanted to play God, but God was having none of it. Not possible. All so destructive and self-destructive.

Jesus totally reverses what Adam did. He lets go of his divinity, let's go of being equal with God, emptying himself of earthly needs. Letting go of his Godhead, which we see in his temptations in the desert. This is the point of Paul's reading today. One of the most sublime, poetic and brilliant pieces of Holy Scripture. The five last and simple verses wrapping up our total belief. The descent of Jesus to the cross as a criminal, to his triumphal resurrection to being with God on high.

Like the archer, we must not let our talents, skills and beautiful natures become distorted because we insist on the wrong things. How much can we let go, so as our inherent beauty and talents for life will last and shine?

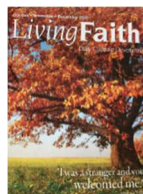

### **ISOLATED DUE TO CORONAVIRUS - HOW TO OBTAIN HELP**

The source of your support depends on which category of 'shielding' you fall into.

**Category 1** - you have been contacted by the NHS and told to remain at home for 12 weeks. You are being supported directly from the government. If you were not contacted by the NHS and told this then you do not fall into this category.

**Category 2** - anyone over the age of 70, plus anyone under the age of 70 with certain serious health conditions plus pregnant women - you are being supported by Essex County Council through their Essex Welfare Service. Please contact them on 0300 303 9988.

**Category 3** - Everyone else.

You are supported by the **new helpline** set up by Rochford District Council in partnership with local faith groups, churches and voluntary organisations. If you have no friends or family close by and you need support during this crisis, or are feeling isolated, please call **01268 779999**.



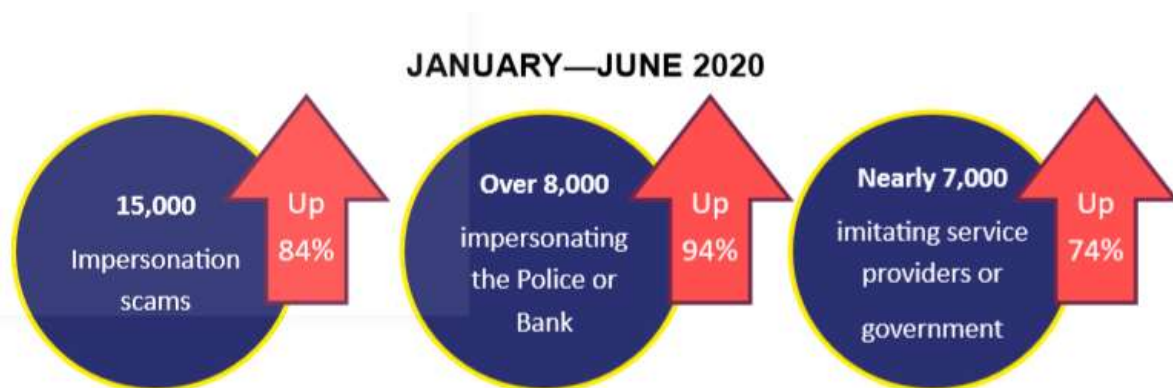


### IMPERSONATION SCAMS ALMOST DOUBLE IN FIRST HALF OF 2020 AS CRIMINALS EXPLOIT COVID-19 TO TARGET VICTIMS

- Almost 15,000 impersonation scam cases reported in the first half of 2020, up 84 per cent compared to the same period last year
- £58 million lost to impersonation scams in January to June 2020, up three per cent on the previous year
- Public urged to beware of criminals exploiting Covid-19 to impersonate the police, banks, or government organisations

UK Finance is urging people to be aware of criminals exploiting Covid-19 to target their victims, after figures revealed a sharp rise in impersonation scams in the first half of this year.

Impersonation scams occur when the victim is convinced to make a payment to a criminal claiming to be from a trusted organisation. This could include the police, a bank, a utility company, or a government department.

Scams involving the criminal impersonating a bank or the police often begin with a phone call or text message claiming there has been fraud on the victim's account. The customer is then convinced that to protect their money they must transfer it to a 'safe account' which actually belongs to the fraudster. Other common scams involve text messages or emails claiming a victim must settle a fine, pay overdue tax or return a refund that was given by mistake.

**Covid-19** related impersonation scams include:

- Criminals claiming to be from an airline or travel agency, offering refunds for cancelled flights or holidays
- Criminals exploiting the growing numbers of people working remotely, by posing as IT departments or software providers and claiming that payments are needed to fix problems with people's internet connection or asking for remote access to the victim's computer.

Criminals will tend to research their targets first, using information gathered from other scams, social media and data breaches in order to make their approach sound genuine. They will also often try to rush or panic their potential victims into making a payment, for example by claiming their money is at risk or their account will be blocked unless they act.

The banking and finance industry has put in place a range of measures to combat impersonation scams. This includes the Banking Protocol, a scheme that allows bank branch staff to alert police to suspected scams and which prevented £19 million of fraud and led to over 100 arrests in the first half of this year. The industry is also working closely with Ofcom to crack down on number spoofing and with the mobile phone industry to block scam text messages including those exploiting the Covid-19 crisis.

UK Finance is also urging the public to follow the advice of the Take Five to Stop Fraud campaign, which offers straight-forward and impartial advice to help people spot scams and protect themselves against fraud.

## COURIER FRAUD BACK ON THE RISE

Essex Police ran a successful operation in January resulting in a number of arrests for offences known as courier fraud. This is where people receive phone calls from criminals claiming to be police officers and requesting that residents withdraw money from their bank accounts, often asking them to lie about the reasons for the withdrawal.



These callers claim to be from a variety of police forces, including Bedfordshire, Suffolk and 'Hammersmith Police'. Recently, callers have stated that someone has been arrested who has provided the recipients address as their own, or has bank cards belonging to the recipient in their possession. They will then advise that the recipient contact their bank—often keeping the line open so that the criminals can pretend to be a bank employee. They will then arrange another criminal to act as a 'courier' to come and collect the cash or bank cards.

If you are unsure whether a call is genuine, remember:

- **Hang up**—feel empowered to hang up and call back on a trusted number (such as the one on the back of your bank card). Never use a number provided by the caller. If possible, use a different phone, or wait five minutes before calling back to ensure that the line has disconnected. You have the right to confirm who you're talking to.
- **Talk about it**—talk to a friend or family member about it. They will quickly tell you whether it sounds suspicious.
- **Tell2**—these criminals target the elderly and most vulnerable members of society, but awareness is key to beating them! Tell2 empowers you to discuss crime prevention messages with others, who otherwise may never know. Tell2 people and ask them to do the same. An unbroken chain of 26 tell2'ers would reach 67 million people!

## Pension Scams

During these times of uncertainty there are increased offers of financial investment and figures from the Financial Conduct Authority and the Pensions Regulator show over £30 million has been lost to pension scams since 2017.

Fraudsters will target pension pots large and small with losses anywhere between £1,000 and £500,000.



Some **Top Tips** on how to protect your retirement:

- 1 Know how much is in the pot**—many people admit to not knowing how much money is currently in their pension making it difficult to make informed decisions.
- 2 Do your research**—you wouldn't make any sort of large purchase without checking the product out first. I should be the same with financial decisions! Take your time to ensure you know exactly what you are purchasing and make use of resources such as the FCA (Financial Conduct Authority) Register to ensure that the firm is registered or speak to a financial advisor.
- 3 Don't be overconfident**—nearly two thirds of people (65%) say they feel that they would be confident in spotting a scam, and yet many would still unknowingly put themselves at risk, with nearly 40% of people saying they would be swayed by tactics such as 'limited time offers'
- 4 Spot the signs**—as above, be wary of 'limited time offers', legitimate firms will never try to panic you or push you into making a rushed decision. Many scams also promise 'guaranteed high returns' on your savings and most offers will be as a result of unexpected emails, phone calls or social media messages.

## Government Number 'Spoofing'

The government has issued a warning following a number of scam calls being made that appear to come from a legitimate government telephone number. The number is that of the Government Legal Department and fraudsters are attempting to scare people into making payments by telling them they will be arrested if they refuse.

A Government spokesman said:

"We have been made aware that the Government Legal Department (GLD) general enquiry number (020 7210 8500) is being used by fraudsters to try and extract money from members of the public.

In most of the reported cases, the fraudsters claim they are calling from GLC or HMRC, with the GLD enquiry line number showing in the caller ID.

They are usually very aggressive on the phone, threatening members of the public that if they do not pay a certain amount of money, the police will arrest them. The calls are NOT being made by GLD or HMRC.

GLD will never call you from its enquiry line number. We will never ask you for your bank details or to pay us money over the phone.

If you receive a call of the type described above, please hang up and call Action Fraud on 0300 123 2040 immediately. When making your report, please ask for it to be associated with report reference NFRC200803859141."

Scammers can make any name or number show up on your caller ID. That's called spoofing.

How it can happen:



1. Scammers use automated dialing software to set up robocalls.



2. They decide what to display on your caller ID. It could look like a local call.



3. They start calling, and can make millions of calls over internet phone lines in minutes.

What you can do:

Use call blocking. Talk to your phone carrier and read expert reviews about your options.
